



DOWN WITH DUES

- Existing members can acquire a new member and both would have their dues reduced. (Example; Platinum Plus is currently \$497 per month. The new dues would be \$326 per month.) The new member must be the same dues class (or higher) as the existing member. After the 1st new member is obtained under the Down with Dues membership drive, each additional new member gives existing members a \$500 credit for golfing members & a \$250 credit for non-golfing members.
- *Sponsoring members can acquire a new member who is a lower dues class & receive a discounted rate. Contact the business office for rate details.*
- Each member may acquire more than one member, but can only receive the discounted rate one time. Each new member would qualify for the DVD discount.
- Food minimum applies to both existing and new members.
- 2 year commitment – the new member must remain a member for a minimum of 2 years. Obligated for the payment of all applicable dues, fees and charges for a minimum of twenty-four months, including any rate changes.
- If a sponsoring member were to leave before the end of two years, the new member would remain at the DVD discounted rate for the 2 year commitment period. If this member finds another member, they would remain at the discounted rate as long as both remain members.
- After 2 years, if either member leaves the club, the remaining member's dues would go back to the full rate. If either member lowers their class, their dues would go back to the full rate. In both cases, they have the option of finding a new member up till July 4, 2021. The DVD discounted rate will apply during this grace period.
- New members must purchase a \$250.00 share of stock.
- Two new members can join at the same time and qualify for the same program described above.
- Program does not apply to corporate members.

ABOUT THE MEMBER STATEMENT PAYMENT PLAN

WHAT IS THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN? The Automatic Member Statement Payment Plan is a convenient way to pay your monthly statement at no extra cost to you. We automatically draft (debit) the amount of your monthly bill from your bank account. You avoid late fees, postage, checks, mailing and having to pay in person. It's all electronic -- all you do is maintain a sufficient bank account balance.

HOW DO I SIGN UP? Just complete and sign the application, attach a voided check and return it to:

HOW MUCH DOES THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN COST? Twin Hills does not charge for this service. It is free. Charges will only be assessed for insufficient funds at \$30 per occurrence (same as returned check fee).

WHEN WILL MY ACCOUNT BE DRAFTED? Your bank account will be drafted on the 15th of each month, or the following business day if the due date falls on a holiday or weekend.

WHEN WILL THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN START? You will be notified by a message on the bottom of your statement before your first draft. You may stop paying by check when you see a special bill message on the bottom of your bill, which will state the date we will draft your payment. There is no cancelled check, but your bank statement will show the amount, date and "ACH Transfer-Twin Hills" as payee.

HOW DO I STOP AUTOMATIC MEMBER STATEMENT PAYMENT? You may stop by notifying us, in writing, of your wish to discontinue paying automatically. Please allow Twin Hills and your bank a reasonable opportunity to act on the termination (approx. 2 weeks). Once terminated, you will no longer see the draft message and you will need to pay by cash or check.
