## Initiation Fee:

The initiation fee is \$1000 for golfing members and \$500 for social members. The initiation fee can be paid upfront or paid out monthly over a 12 month commitment period.

## Stock

All classes must purchase a share of stock for \$250.00 with the application.

## Food Minimums

There is a monthly food minimum purchase of \$75.00 for family memberships and \$55.00 for single memberships with the exception of Junior Family & Junior Single. Junior Family will have a food minimum of \$55.00 & Junior Single will have a minimum of \$40.00. The food minimum for single members age 75 & older is \$40.00. Beverage purchases and gratuity are not credited against the minimum.

**Member last name beginning L – R Minimum Cycle 14<sup>th</sup> – 13<sup>th</sup>**

(Minimum cycle begins the 14th of the month through the 13th of the next month)

**Member last name beginning S – Z Minimum Cycle 21<sup>st</sup> – 20<sup>th</sup>**

(Minimum cycle begins the 21st of the month through the 20th of the next month)

## **ABOUT THE MEMBER STATEMENT PAYMENT PLAN**

**WHAT IS THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN?** The Automatic Member Statement Payment Plan is a convenient way to pay your monthly statement at no extra cost to you. We automatically draft (debit) the amount of your monthly bill from your bank account. You avoid late fees, postage, checks, mailing and having to pay in person. It's all electronic -- all you do is maintain a sufficient bank account balance.

**HOW DO I SIGN UP?** Just complete and sign the application, attach a voided check and return it to:

**HOW MUCH DOES THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN COST?** Twin Hills does not charge for this service. It is free. Charges will only be assessed for insufficient funds at \$30 per occurrence (same as returned check fee).

**WHEN WILL MY ACCOUNT BE DRAFTED?** Your bank account will be drafted on the 15<sup>th</sup> of each month, or the following business day if the due date falls on a holiday or weekend.

**WHEN WILL THE AUTOMATIC MEMBER STATEMENT PAYMENT PLAN START?** You will be notified by a message on the bottom of your statement before your first draft. You may stop paying by check when you see a special bill message on the bottom of your bill, which will state the date we will draft your payment. There is no cancelled check, but your bank statement will show the amount, date and "ACH Transfer-Twin Hills" as payee.

**HOW DO I STOP AUTOMATIC MEMBER STATEMENT PAYMENT?** You may stop by notifying us, in writing, of your wish to discontinue paying automatically. Please allow Twin Hills and your bank a reasonable opportunity to act on the termination (approx. 2 weeks). Once terminated, you will no longer see the draft message and you will need to pay by cash or check.
