### Initiation Fee:

The initiation fee is \$1000 per golfing member and \$500 for social member. Waived with a 2-year commitment.

### Stock:

All classes must purchase a share of stock for \$250.00 with application.

### Food Minimums & Capital Dues:

There is a monthly food minimum purchase of \$75.00 for family memberships and \$55.00 for single memberships. Young Executive Family food minimum is \$50.00 and Single is \$35.00. Junior Family will have a food minimum of \$40.00 and Single will have a minimum of \$25.00. The Social food minimum is \$25.00. Beverage purchases and gratuity are not credited against the minimum.
